- Keep left to take the ramp toward Johnson Creek / WI-26 S / Jefferson..... 0.07 mi.
- Turn left onto WI-26 S..... 0.9 mi.
- Turn right onto CR-B / Milwaukee St 0.4 mi.
- Turn slight left onto CR-B / Aztalan St. Continue to follow CR-B..... 1.6 mi.
- Turn right onto CR-N..... 2.7 mi.
- Turn right to stay on CR-N 2.2 mi.
- CR-N becomes French Rd. Continue to follow French Rd 1.1 mi.
