Turn left onto Texas 237 S, go 0.2 mi  
Turn right onto Main St, go 282 ft  
Turn left onto Farm-To-Market Rd 1457 E/?Live Oak St  
Continue to follow Farm-To-Market Rd 1457 E, go 12.8 mi  
Turn left onto TX-159 E, go 8.6 mi  
Sharp right onto Skalak Rd, go 0.3 mi  
Turn left to stay on Skalak Rd, go 1.4 mi  
Turn right to stay on Skalak Rd, go 3.1 mi  
Sharp right onto New Bremen Rd, go 0.9 mi
