The Junior and Master tests will start promptly at 8:00 a.m. in both fields. The test headquarters will be at the AmericInn in Hutchinson. The bathrooms of the clubhouse will be available to use.

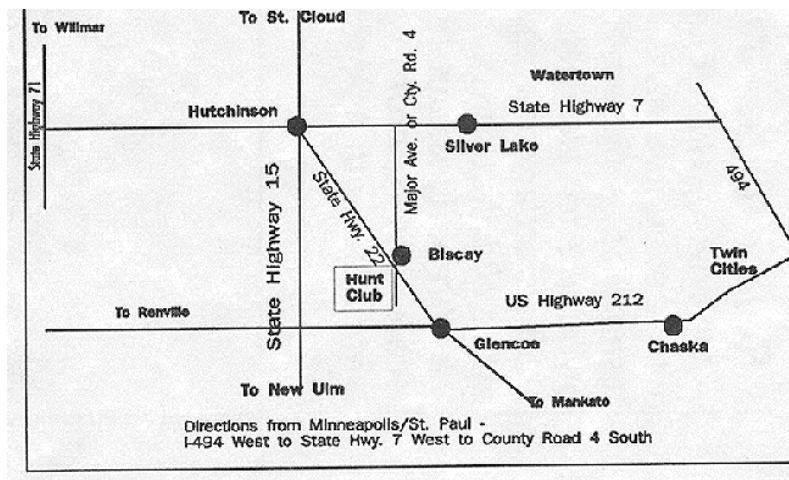
