Directions to the Event Grounds

NOTE: The Hussey Well Field is not going to show up well on any GPS as the field road leading from White Mountain Highway to the trial site is called Dugway Road and is generally unmapped. Use 3582 White Mountain Hwy, North Conway, NH 03860 which is the address for the 1785 Inn and Dugway Road is a gravel road approximately 100' south of the 1785.

Directions from Portsmouth NH and other points south – Take the Spaulding Turnpike north where it becomes NH Route 16. Continue on Rte 16 northward through Wakefield, Ossipee, Tamworth, Albany, Conway etc into North Conway. Stay on Rte 16 North through the North Conway shopping “strip” through North Conway Village and after the village, look for the 1785 Inn on the left, about five to ten minutes north of the village.

Directions from the west - Find your way to the lakes region of New Hampshire, specifically Meredith. From Meredith, take RTE 25 through Center Harbor, Moultonborough and South Tamworth to the intersection of RTE 25 and RTE 16 in West Ossipee. From West Ossipee, take RTE 16 north into Conway and North Conway. See directions above for remainder of route.

Directions from the east – From Maine, take available routes to Fryeburg. From Fryeburg take route 302/113 west into New Hampshire, entering into Center Conway. Stay on route 302/113 west for about 4.5 miles where you'll take route 302 to the right, to North Conway. Route 113 continues straight towards Conway. Follow route 302 to route 16 on the shopping “strip” of North Conway. See directions above for the remainder of the route.
