## **Directions:**

**GPS: WMBDC - 87 Farnum Road, Granville, Ma -OR- 87 Charles Farnum Road, Blanford, Ma (google maps)**

### **Directions from Mass Pike**

**Mass Pike (rt90) to Exit 3 (Westfield).  
Left off exit go 1.5 miles to Rt.20 west (CVS at corner)  
Take a right onto Rt.20 west.  
Follow Rt.20 to Rt.23  
Take a left onto Rt.23  
Drive 7 miles to Beech Hill Rd. on left.  
Take Beech Hill Rd. (3.5 miles) to Farnum Rd. (Charles Farnum) on right.  
There is a WMBDC sign at the beginning of Farnum Road.  
Club is 600 yards up on the left**

### **Directions from route 57**

**Travel 24.8 miles on Route 57W to North Lane in Granville  
Take a Right onto North Lane  
(follow sign for Ripley Maple Corner Farm)  
In 2 miles Take left onto Broden Brook Rd.  
End of Broden Brook take a left onto Beech Hill Rd.  
Drive approx. 1 mile and take first left Farnum Road (dirt road) after Riples Corner Farm  
There is a WMBDC sign at the beginning of Farnum Road.  
Club is 600 yards up on the left**

## **Judging Requirements:** (note each parent club has different requirements)

### How to become a Cocker Spaniel AKC Field Trial Judge

1. Attend an AKC Spaniel Field Trial Judging Seminar prior to apprenticing at a field trial
2. Complete two (2) Apprentice Judging Assignments under two different AKC Senior judges.
3. The Apprentice assignments shall be completed at an AKC approved Field Trial Stake
4. Apprentice should receive prior permission from the local Field Trial Committee.
5. The Senior Judge should be contacted by the local trial committee and agree to the assignment.
6. The standard AKC Apprentice form must be completed by the Senior Judge and submitted to the AKC for recording purposes with an additional copy supplied to the ECSCA FTC Chairman.

### How to become a Springer Spaniel AKC Field Trial Judge

1. Attend a Parent Club approved JUDGES SEMINAR.
2. Pass a Parent Club prepared written test.
3. Pass two (2) APPRENTICESHIPS.\* (An Apprentice Evaluation Form MUST be filled out and approved/passed by each Teaching Judge. If the Apprentice is not approved/passed by either of the Judges, the Apprenticeship for that trial will NOT count.)
