However, here are directions to the Old Hallandale Hunt Club-

Travel North on I-99 (new Rt 220) and take the Bellwood #exit 41 (Rt 865)

at the exit ramp stop sign, Turn Right, and drive over Skelp Mountain

at the stop sign in the small town of Skelp, turn right

Go one half mile to a stop sign-GO STRAIGHT THROUGH

Go 1 and 1/2 miles to a stop sign (this road makes a couple of dog legs)

At the stop sign, farm, office, and kennel is 1/2 mile to the left

Club House is one quarter mile to the right, across from the Lutheran Church
