Other refunds are at the discretion of the Field Trial Committee. After closing time refunds will be less \$10.00 to cover administrative expenses. Entry fees include: \$.50 AKC recording fee, \$3.00 AKC Event Service Fee, and \$1.00 admission fee per entered dog. Admission fee for non-participants is \$1.00 per day.
