Directions To Hunting Test Site

From Points North (off I-95): Take Rt 896 South towards Glasgow. Follow Rt 896 approximately 7.2 miles to Rt 71. Turn left onto Rt 71 (if you go over the canal, you have gone too far). Go 2.3 miles. Turn right onto Steele Road (which becomes Woods Road in MD). Go 1.4 miles. Turn right into Rebel Ridge Farms, Inc.

From Points South (off I-95): Take exit for Rt 279 South. Follow Rt 279 for a few miles. Turn left onto Rt 213 South. Follow Rt 213 for approximately 4.5 miles (if you go over the canal, you have gone too far). Turn left onto Elk Forest Road. Take an immediate right onto Knights Corner Road. Proceed 0.4 miles. Turn left onto Woods Road. Go 0.7 miles. Turn left to 295 Woods Road, Rebel Ridge Farms, Inc.
