A dog with an AKC Limited or Conditional Registration shall be eligible.

Directions

Take the 14 through Palmdale/Lancaster to Mojave. Stay on the 14 out of Mojave. It is a right turn at the end of town. It is about 18-20 miles to the turn off.

At Jawbone Canyon Store / motorcycle park (on your left) wake up. The turn off is just after it to the right.

Exit Highway 14 at Rogers Rd.

Go to the end (1/2 mile) and turn right on Neuralia Rd.

Go 100 yards and just after the railroad track turn left onto Cantil Rd. heading east. Go a couple of miles to a 3-way fork.

Take Valley Rd, the center fork. Go to the end, about a mile.

Turn left on Pappas Rd. Go to the end, about 1/2 mile. The road curves right and becomes Lake Rd.

Go to the end of the road to the entrance to Flowing Wells Ranch. There is a white gate with FWR in black above it. Drive on through past the brown double wide on your right and you will find the main house.
