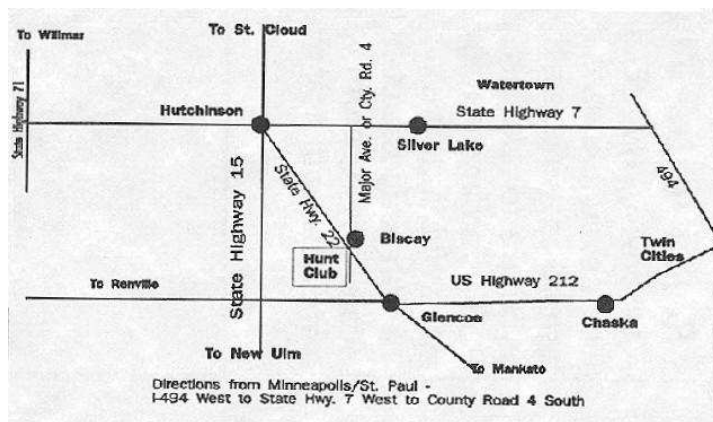
Directions from Minneapolis:

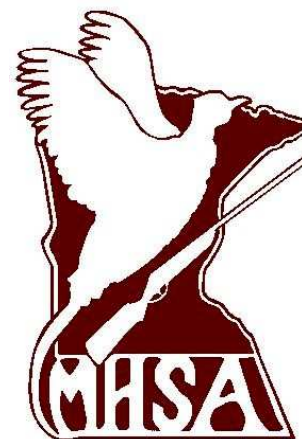
