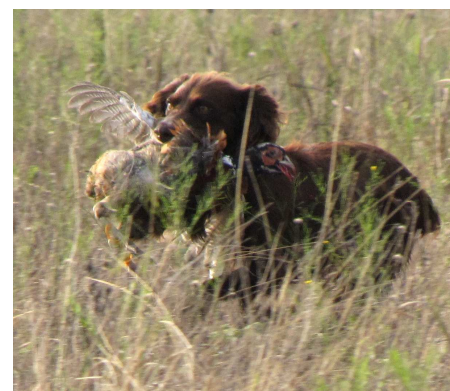

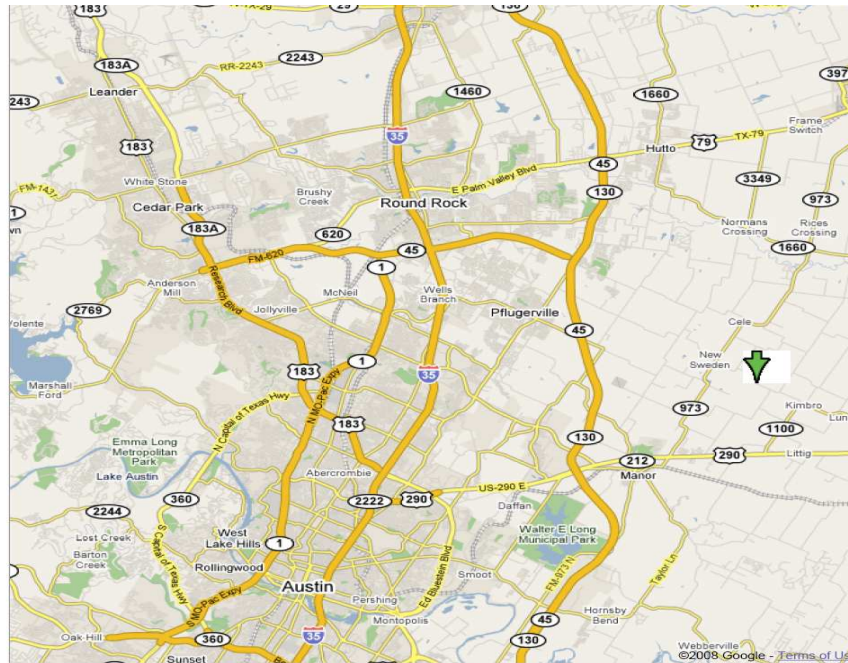

- Pheasant will be used for the Open Stake. Pigeons or pheasant will be used for the Puppy Stake. The club reserves the right to substitute any game birds, based upon availability, per AKC rules.
- The AKC and the Heart of Texas Spaniel Club require all persons in the field to wear blaze orange, not smaller than a hat
- Entry fees will be refunded only for (1) a bitch in season with a note from a vet, (2) a dog that is injured, ill or dies with a note from a vet or (3) an entry cancelled prior to the closing date.

## Directions to the DoubleDogDareYa Ranch, 13201 Jacobson Road, Lot 2, Manor, TX 78653



- **From San Antonio** take IH-35 to US Highway 290 East, go East 10.7 mi, turn left onto FM 973, go 4.7 mi, turn right onto New Sweden Church Rd, go 0.9 miles, turn right onto Jacobson Road, go 1.1 miles to 13201 (row of mailboxes on the right); turn right and go all the way to the end of the drive 0.7 miles.
- **From Dallas** take IH-35E S toward Waco - go 161.8 mi, take exit #265/Austin Continue on TX-130-TOLL S - go 21.7 mi, take exit #432/Pecan Street /Cameron Road 1.1 mi, Turn Left on Cameron Road - go 3.7 mi, turn right on Schmidt Lane - go 1.5 mi, turn left onto FM-973 N(FM-973) - go 0.8 mi, turn right on New Sweden Church Road - go 0.9 mi, turn right on Jacobson Rd - go 1.1 arrive at 13201 Jacobson Road, (row of mailboxes on the right); turn right and go all the way to the end of the drive 0.7 miles.
- **From Houston**, take Highway 290 East to Elgin; turn right onto TX-95 North; turn left at the first light onto FM 1100; continue on FM 1100 5.5 miles; turn right onto Manda Rd. and go 1.1 miles, turn left onto Manda Carlson (immediately changes name to Jacobson) and go 0.9 miles to 13201 (row of mailboxes on the left); turn left and go all the way to the end of the drive 0.7 miles.
